The Council must co-opt to fill the vacancy (under Rule 5(5) of the Local Election (Parishes and Communities) Rules 2006). The Council should advertise the co-option and publishing a co-option notice would be good practice. The Parish Council agreed to display the advert for the casual vacancy on the Newbiggin Village Noticeboard and the Parish Council website and a copy to be e mailed to the Newbiggin resident who had expressed an interest.
