- Thoralby Village Sign near Mill Bridge House Attempts have been made to clean it but it is beyond cleaning as debris has penetrated the plastic.

- Bishopdale Bridge Cllrs confirmed that a truck had driven into the bridge causing significant damage. The
 matter had been reported to the Police and Highways. Cllr Peacock said that she hoped the long awaited
 Capital Project for a new bridge scheme would now be expedited.
- Cllr Wilman reported that a car had been stuck in water at Holme Lane Goose Lane, Thoralby. Cllrs asked whether Highways would install a 'Dead End' or 'Road not accessible' sign. Action - Clerk to e mail lan Beighton

• Hedges from top of Dyke Hollins Lane, Aysgarth down to Thoralby village - Cllrs reported that these needed cutting back as restricting the width of the road making it a dangerous single track road.
