- Cllr Dinsdale said that he had asked WBW to manage the BPS when they agreed original scope of work. Given the above problems Cllr Dinsdale said he would arrange a meeting with John Akrigg to resolve the issues.
- The Parish Council agreed to hold off paying WBW invoice 4018/27 until after Cllr Dinsdale had spoken to WBW Surveyors.
